



MEETING MINUTES FEBRUARY 11, 2021

Call to order

A meeting of the Canyon Lake Triathlon and Fitness Club was held at the Cabo Room on February 11, 2021. The meeting was called to order at 7:05 p.m.

Business

Treasurer's Report – We have \$3,234.55 in our checking account, plus \$791.72 in PayPal and \$100 cash, totaling \$4,126.27.

Insurance renewal – Lainie is trying to reach USAT and will also check into officer's insurance to protect our Board Members.

Trailer Storage – The trailer has been stored at Johncee and Kevin Cochrane's property and the club has historically made a donation to CLAMS (Canyon Lake Association of Men) in appreciation. A motion was made to make a 2021 donation (amount donated last year or not to exceed \$200) and motion was approved. In addition, in anticipation of using the trailer for May and ongoing events, we are seeking volunteers to inspect and do some trailer TLC. Contact Maria if interested.

Heart and Sole 5K/10K Race – is taking place this Saturday, for Club Members. We don't know how many will participate since this is self-supported and registration is not required. Robert can rove

the course in his golf cart if support is needed and Matt will bring his as well. Laura Heglund has volunteered to be at the intersection of CLD/Vacation if support is needed.

The group outlined a schedule of events for the remainder of 2021. Dates and details may be impacted depending on COVID restrictions. Point person is in parentheses:

Bike Maintenance Clinic – (Matt) Wednesday March 10th at 6:00 p.m. (Before the March meeting) This will cover basics – tire inflation, flats and basic maintenance.

Bike Time Trial – March 20 or 21 (Becky) This was a lot of fun when we did it in October. Some people did not receive their previous time trial results, so if they are available, it would be great to send them out prior to the March event so people can compare their results. Date to be finalized pending conversation with Becky.

Tour de Canyon Lake – April 17th. (Karin) Group bike ride through the community. If protocol permits, we will invite community participation. We will collect donations for Animal Friends of the Valleys, as we have done in the past.

Sprint Triathlon – May 15 (Lainie)

Olympic Triathlon – June 19 (Point persons TBD)

Kids/Family Triathlon – July 17. (Point persons TBD) This will be a super sprint for the adults and a shorter distance for the kids. In lieu of the evening bar-be-cue, this will be a Saturday morning event with morning snacks.

Paddle N Pedal Regatta – August 14th. (Karin) If protocol allows, we will once again host this event for the community, as a charity fundraiser. Members are invited to suggest a charity beneficiary. Past beneficiaries have been Relay for Life, the American Cancer Society and Kamalii Foster Family Agency. If Covid restrictions prevent a community gathering, we will instead have a club member only swim and paddle event.

Metric IM – September TBD – This will be a perfect event for those participating in October/November IM's. There will be relay options for those who would like to participate in one or multiple legs.

October 16th – 5K or another event TBD.

November 25th – Turkey Trot 5K/10K Run – If protocol permits, the community will be invited.

December 16th – Holiday Party

Swimming Clinics -- We would also like to consider swimming clinics once the pool opens (March 15th). Maria will reach out to Doug and see if he can commit to hosting a clinic or series. We would also like to see if any evening time can be reserved for lap swimming during the week. Lainie will reach out to the POA to inquire.
